SUMMER GATHERING

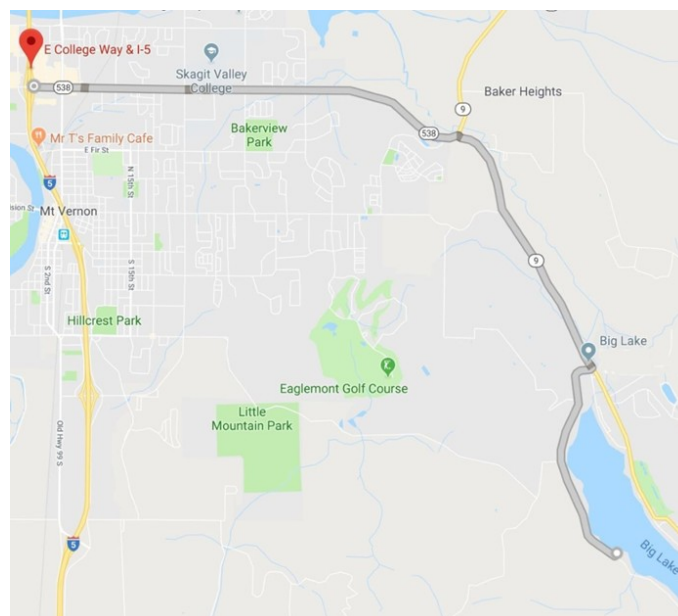

Follow Big Lake Boulevard around the south side of Big Lake, past the Big Lake Resort. 18279 is about 8/10th of a mile past the resort on the lake side.
